OVERVIEW

A-Cubed Consulting (as Ports of Africa) was retained in July 2009 by JSPL (Jindal) to undertake a Logistics Feasibility Study for their Songo coal mining concession near Tete, central Mozambique.

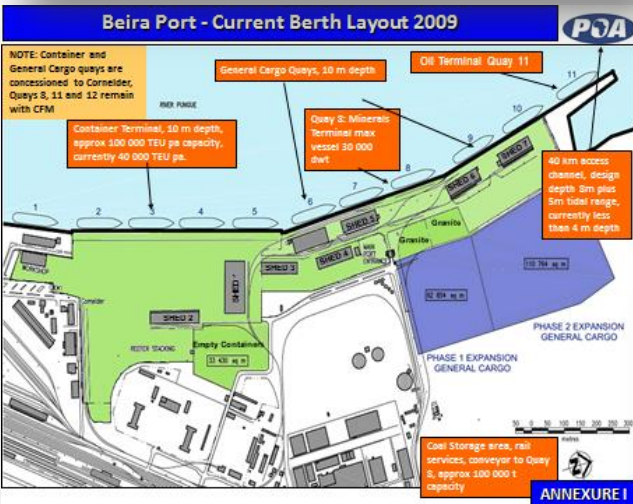
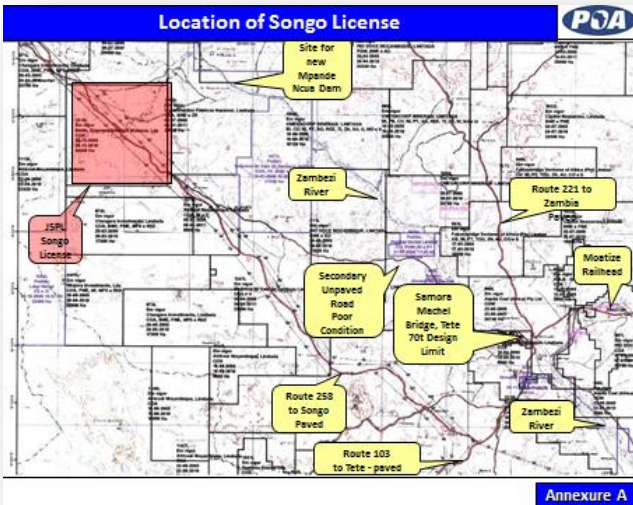
The growing demand for logistics capacity by new mining concession holders and the limited supply available in the foreseeable future required that new producers look at alternatives means to get their product to market. The geographical implications of the mine site being on the southern bank of the Zambezi River also presented further logistical challenges.

SCOPE OF WORK & METHODOLOGY

This assignment entailed a site visit to the mine, an investigation of the possible logistics options and a visit to Beira to meet with port authorities and rail concessionaires. A-Cubed also drew on their extensive experience with similar greenfield operations in this area.

The following tasks comprised the scope of work:

- an investigation of the likely alternatives available in transport infrastructure to a suitable port; the condition of the infrastructure, its capacities, constraints and present and future throughput;
- an assessment of the available transport routes and the identification of appropriate transport methodologies, including transport options and intermodal road transport/rail options;
- an investigation of planned regional transport infrastructure that may have a bearing on the Songo concession;
- to investigate port options and the situation with respect to new terminals being developed, existing terminals being upgraded and their potential for JSPL's exports;
- an assessment of the transport logistics risks and possible risk mitigants;
- to develop CAPEX and OPEX financial logistics models, from mine to FOB.
